Maryland PSC Schedules First Public Hearing for Queen Anne's County Solar Project

(BALTIMORE, MD-April 17, 2019) – The Maryland Public Service Commission will hold a public comment hearing on the application of Bluegrass Solar, LLC to build an 80 MW solar generating facility in Queen Anne's County, Maryland. The hearing will be held on **Wednesday, May 1, 2019, at 6:30 p.m. at Church Hill Elementary School, 631 Main Street in Church Hill.** Members of the public who wish to comment on the proposal are welcome to attend the hearing before Chief Public Utility Law Judge Ryan C. McLean. A second public comment hearing is planned for June 2019 at a date, time and location to be determined.

According to the application, the solar array will be constructed on 487 acres north of Church Hill, east of State Route 213 and north of State Route 300, in Queen Anne's County. The application is available for public inspection or copying at the Queen Anne's County Office of Planning & Zoning, 110 Vincit Street, Centreville, Maryland 21617.
