## **Maryland Public Service Commission Schedules Public Hearings for Egypt Road Solar Project in Dorchester County**

(BALTIMORE, MD-May 19, 2017) – Two public comment hearings will be held on the application of Egypt Road Solar Center, LLC to construct a 45.9 MW solar generating facility in Dorchester County. The first hearing will be held on **Thursday, June 1, 2017 at 6:30pm** at the **Dorchester County Public Library, 303 Gay Street in Cambridge**. The second hearing is scheduled for **Monday, July 10, 2017 at 6:30pm** at the **Holiday Inn Express, 2715 Ocean Gateway in Cambridge**. Members of the public who wish to comment on the matter are welcome to attend the hearings before Chief Public Utility Law Judge Terry J. Romine.

According to the application, the solar facility will be constructed on approximately 320 acres across two properties in the southernmost portion of the City of Cambridge. The property is currently zoned residential by the City, but the applicant has met with the City Planning Commission to discuss a potential change in zoning.

A copy of the application is available for public inspection and copying at the City of Cambridge Department of Planning and Zoning, D.P.W., 1025 Washington Street, Cambridge.
