## **NOTICE INITIATING RULEMAKING (RM71) AND**

## **NOTICE OF VIRTUAL RULEMAKING SESSION**

The Maryland Public Service Commission hereby initiates an Administrative Docket, RM71, to consider new regulations to be codified as COMAR 20.55.10.01, .02, and .03. On October 27, 2020, on behalf of the Professional Engineer Work Group, the Commission's Technical Staff ("Staff") submitted a Petition for a Rulemaking seeking to adopt regulations regarding Licensed Professional Engineer ("PE") approval and stamping of natural gas infrastructure projects in Maryland.<sup>1</sup> The background, purposes, and text of the proposed regulations may be found in Staff's petition.

Comments on the new COMAR Chapter, 20.55.10, shall be e-filed by Friday, November 20, 2020.<sup>2</sup> The comments should be addressed to Andrew S. Johnston, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, St. Paul Street, 16<sup>th</sup> Floor, Baltimore, Maryland 21202.
