The Maryland Public Service Commission hereby gives notice that it will conduct in-person only, legislative-style hearings on October 22, 23, and 24, 2024, beginning at 10:00 a.m., in the Frank O. Heintz Hearing Room, 16<sup>th</sup> Floor, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland to consider the revised 2024-2026 EmPOWER Maryland plans of The Potomac Edison Company,<sup>1</sup> Baltimore Gas and Electric Company,<sup>2</sup> Delmarva Power & Light Company,<sup>3</sup> Potomac Electric Power Company,<sup>4</sup> Southern Maryland Electric Cooperative, Inc.,<sup>5</sup> and Washington Gas Light Company.<sup>6</sup>
