PUBLIC UTILITY LAW JUDGE'S NOTICE OF MODIFIED PROCEDURAL SCHEDULE

In order to provide time for settlement discussions, the parties and this Public Utility Law Judge have agreed to extend the procedural schedule in this matter for an additional 30 days. Sandpiper Energy, Inc. has requested that its proposed rates and charges become effective on February 1, 2016, as opposed to January 1, 2016, to allow for the extended schedule. The agreed upon revised procedural schedule is as follows:

March 18, 2016 - Evening hearing for public comment.

March 21, 2016 - Staff, OPC and Intervenors file reply testimony.

April 4, 2016 = Parties file rebuttal testimony

April 14, 2016 - Parties file surrebuttal testimony.

April 18-20, 2016 Sevidentiary hearings.

May 16, 2016 = Initial briefs due.

May 31, 2016 Reply briefs due.

June 20, 2016 - Target date for Proposed Order.

July 1, 2016 - Any notice of appeal, accompanied by the memorandum on appeal, due.

July 29, 2106 - Statutory review period expires.

A response to a data request served by any party before April 4, 2016 shall be due no later than seven business days after the request has been served. After the filing of rebuttal testimony on April 4, responses will be due within five business days. Any objection to all or part of a data request shall be made within three business days after the request has been served.

The scheduled evidentiary hearings will be held in the Commission's 19th floor hearing room, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland. The hearing scheduled for April 18 will commence at 11:00 a.m.; the evidentiary hearing will continue to April 19 at 10:00 a.m. and April 20 at 1:00 p.m., as necessary.

The evening hearing for public comment set for March 18, 2016 will commence at 7:00 p.m. in the cafeteria at Stephen Decatur Middle School, 9815 Seahawk Road, Berlin, Maryland. Customers wishing to comment on Sandpiper Energy, Inc.'s proposal may do so at the evening hearing or in writing. Written comments, referencing Case No. 9410, should be sent to David J. Collins, Executive Secretary, Maryland Public Service Commission, William Donald Schaefer Tower, 6 St. Paul Street, Baltimore, Maryland 21202-6806, by April 15, 2016.
