## Second Public Comment Hearing February 3 on 5.0 MW Solar Plant Proposed for Prince George's County

(BALTIMORE, MD) – Local residents and other interested members of the public are again invited to comment on a proposal by Croom Road Solar, LLC to construct a 5.0 MW solar generating facility in Prince George's County. The hearing will take place on **Monday, February 3, 2025 at 6:00 p.m.** at the Town Hall of Upper Marlboro, 14211 School Lane in Upper Marlboro. Public Utility Law Judge Christine L. Burke will preside. The first public comment hearing in this case was held on October 24, 2024.

In June 2024, Croom Road Solar applied to the Maryland Public Service Commission for what is known as a Certificate of Public Convenience and Necessity (CPCN), which grants an applicant the authority to construct an energy generating station or high-voltage transmission line in Maryland. According to the application, the solar facility, intended as part of Maryland's community solar program, would be built on approximately 25 acres of a 40-acre parcel at the intersection of Croom Road and Route 301 (Crain Highway) in Upper Marlboro. The project site is an abandoned brownfield previously used as an unpermitted sand and gravel mine.

The hearing will include a virtual option for those unable to attend in person. Participants will receive an email with the link to join in on the virtual platform. The hearing will include a presentation by the developer, followed by brief statements from the Power Plant Research Program of the Maryland Department of Natural Resources, the Maryland Office of People's Counsel, and the Commission's Technical Staff, and then an opportunity for members of the public to comment on the proposed project.
