Second Public Comment Hearing February 4 on 4.0 MW Solar Plant Proposed for Montgomery County

(BALTIMORE, MD) – Local residents and other interested members of the public are again invited to comment on a proposal by Chaberton Solar Sugarloaf I, LLC to construct a 4.0 MW solar generating facility in Montgomery County. The hearing will take place on **Tuesday, February 4, 2025 at 6:30 p.m.** at the Upper Montgomery County Volunteer Fire Department, 19801 Beallsville Road in Beallsville. Public Utility Law Judge Jennifer J. Grace will preside. The first public comment hearing in this case was held on July 10, 2024.

In March 2024, Chaberton Solar Sugarloaf applied to the Maryland Public Service Commission for what is known as a Certificate of Public Convenience and Necessity (CPCN), which grants an applicant the authority to construct an energy generating station or high-voltage transmission line in Maryland. According to the application, the solar facility, intended as part of Maryland's community solar program, would be built on approximately 16 acres of a nearly 53-acre parcel at 20507 Darnestown Road, near the intersection of Darnestown Road and Dickerson Road, in Dickerson.

The hearing will include a virtual option for those unable to attend in person. To participate virtually, please sign up in advance to speak by sending an email to psc.pulj@gmail.com by noon on February 3, 2025. Participants will receive an email with the link to join in on the virtual platform. The hearing will include a presentation by the developer, followed by brief statements from the Power Plant Research Program of the Maryland Department of Natural Resources; Montgomery County; the Maryland-National Capital Park and Planning Commission; the Maryland Office of People's Counsel; and the Commission's Technical Staff, followed by an opportunity for members of the public to comment on the proposed project.
