NOTICE AMENDING PROCEDURAL SCHEDULE

On September 27, 2022, Delmarva Power & Light Company ("Delmarva") filed a request to cancel the hearings scheduled for in-person testimony in this case beginning on September 27, 2022. That request stated that Delmarva and the other parties to this rate case had reached a partial settlement (the "Settlement"), resolving all disputed issues except those concerning the need for a Bill Stabilization Adjustment and the appropriate reconciliation mechanism (the "Remaining Issues"). On September 27, 2022, the Commission granted the request, canceling the hearings.

On September 29, 2022, Delmarva filed a consensus proposal, on behalf of all parties, regarding scheduling of hearings and briefing on the Settlement and on the Remaining Issues (the "Proposal"). The Proposal called for the parties to file the Settlement on October 7, 2022, and to each file testimony on the Settlement on October 12, 2022. The Proposal also requested the Commission hold a hearing on October 24, 2022, during which the parties will offer into the record the certificates of publication; direct and rebuttal testimonies and exhibits, with any corrections, concerning Delmarva's

application; and the sections of the supporting data and multi-year plan filing requirements that were sponsored by its witnesses in their direct testimonies.

The Proposal asked whether the Commission desires a live hearing to examine the witnesses whose testimony is relevant to the Remaining Issues or whether the Commission is satisfied with the written pre-filed testimonies. The Proposal suggested that, if the Commission is satisfied with the pre-filed testimonies, no live testimony be held and initial briefs be due November 1, 2022, and reply briefs be due on November 14, 2022. The Proposal stated that, if the Commission desires live testimony on the Remaining Issues, the parties will propose a hearing date for Commission approval.

Upon consideration of the consensus proposal, the Commission directs that the schedule for consideration of the Settlement and for resolving the Remaining Issues shall be as follows:

- (1) The parties shall file the Settlement by October 7, 2022;
- (2) Testimony on the merits of the Settlement shall be filed by October 12, 2022;
- (3) The Commission will hold a hearing on October 24, 2022, to receive offered exhibits and address any outstanding issues;
- (4) The Commission grants the parties' proposal to waive live testimony regarding the Remaining Issues;
- (5) Initial briefs, addressing both the Settlement and the Remaining Issues, shall be filed by November 1, 2022;
 - (6) Reply briefs shall be filed by November 14, 2022; and

(7) Each party choosing to brief the Remaining Issues shall, as an exhibit to its brief, file a consolidated copy of all admitted testimony and exhibits by its own witnesses that it considers relevant to those specific issues.
