SUPPLEMENTAL NOTICE OF HEARING AND OPPORTUNITY TO COMMENT

On March 19, 2024, as part of Public Conference 56 ("PC56"), the Public Service Commission issued a Notice of Public Hearing and Opportunity to Comment on electric companies' efforts to procure federal funding since the issuance of Order No. 90272, evaluating their relative successfulness in procuring such funding, and discussing the extent to which such efforts and relative successfulness align with its existing distribution plan and with state policy goals stated under Public Utilities Article ("PUA") §§ 7-802 and 7-803, as well as other comments relevant to these topics. That Notice sought comments by May 1, reply comments by May 22, and set a legislative-style hearing for June 12, 2024.

Following the issuance of that Notice, the Maryland General Assembly passed legislation, expected to take effect October 1, 2024, requiring the Commission to adopt regulations or issue orders expressly requiring electric companies to apply for federal and other

available funds in a timely manner and "to ensure that least-cost debt is used."²
