## Maryland PSC to Hold Public Hearing for Town of Thurmont Rate Request

(BALTIMORE, MD-November 21, 2017) – The Maryland Public Service Commission will hold a public hearing on a request by the Town of Thurmont, Maryland, to increase its electric distribution rates by \$168,150-- an increase of 2.67 percent. Thurmont owns and operates electric distribution facilities to provide electric service to its customers, which are all residents of the Town. The hearing will be held on **Wednesday**, **December 6, 2017**, at **7pm** at the **Thurmont City Hall**, **615 East Main Street in Thurmont (Frederick County), Maryland**.

Members of the public who wish to comment on the matter are encouraged to attend the hearing before Chief Public Utility Law Judge Terry J. Romine.

As described in its application, the Town maintains it needs the increased distribution rates to fund continued electric system improvements and assure that its fiscal year budgets are balanced. This increase is to be implemented concurrently with an expected reduction in total power supply cost collection in 2018. The resulting impact to Thurmont's electric customers would be a net reduction of approximately 3.3 percent.
