### Public Hearing Scheduled in Dorchester County for Todd Solar Project

(BALTIMORE, MD-May 5, 2016) – A public hearing for comment will be held on **Thursday, May 19, 2016 at 7pm** in the matter of the application of Todd Solar, LLC to construct a 20 MW solar photovoltaic generating facility in Dorchester County, to be located on Harper Road in Hurlock. The application has been docketed by the Maryland Public Service Commission as Case No. [9412](#).
